NEW IPSWICH, NH: Andrew J. Melnicki, 65 of New Ipswich, NH, formerly of Lowell, died unexpectedly Monday, March 25, 2019 at Nashoba Valley Medical Center, Ayer.

Mr. Melnicki was born in Lowell, April 2, 1953, a son of the late Leo and Harriet (Sullivan) Melnicki and was a 1971 graduate of Lowell High School. He continued his education at Santa Monica Community College in Santa Monica, California where he majored in Criminal Justice.

He worked as a police officer in Santa Monica for eight years before returning to this area when he went to work as a technician at Verizon. He retired in 2004 after 25 years of service.
